MEMORANDUM OF AGREEMENT

UNIVERSITI PUTRA MALAYSIA

AND

CHULALONGKORN UNIVERSITY

ADDENDUM

THIS ADDENDUM made on this day of in the year 2021.

BETWEEN

UNIVERSITI PUTRA MALAYSIA (hereinafter called "UPM"), an institution of higher learning established under the Universities and University Colleges Act 1971 (Act 30) of Malaysia and having its address at 43400 Serdang Selangor Darul Ehsan, Malaysia and shall include its lawful representative and permitted assigns on the one part;

AND

CHULALONGKORN UNIVERSITY, Thailand for the purpose of this Agreement represented by its Faculty Science and having its address at 254 Chulalongkorn University, Phayathai Rd., Wangmai, Pathumwan, Bangkok (hereinafter to referred to as "CU") and shall include its lawful representative and permitted assigns on the one part. UPM and CU may individually be referred to as "Party" or collectively as "the Parties".

WHEREAS:

- (A) The Parties have previously entered into a Memorandum of Agreement dated 17th August 2016 (hereinafter called "the said MoA") to strengthen, promote, develop academic and research co-operation between the parties on the basis of equality and mutual benefit;
- (B) The said MoA have come into effect on the 17th August 2016 and will expire on 16th August 2021.
- (C) **Article 8** of the said MoA provides that the MoA may be extended for a further period as may be agreed in writing by the Parties and

the Parties have agreed through a letter for a new extension period of five (5) years effective from 17th August 2016 and will expire on 16th August 2021.

NOW THEREFORE the Parties hereby understand as follows:


1. The period of the said MoA is hereby renewed for another period of three (3) years commencing from the 17th August 2021 and will expire on 16th August 2024.
2. This Addendum shall be supplemental to and read as part and parcel of and construed as one with the said MoA.
3. This Addendum is deemed to have come into force on the date of 17th August 2021.
4. The other terms and conditions in the said MoA shall remain effective and valid.
5. Each Party will bear its own costs and expenses in relation to this Addendum.
6. Time whenever mentioned shall be the essence of this Addendum.
7. All appendix attached hereto shall form part of this MoA and if conflict occurs between the terms and conditions of this MoA and the appendix attached hereto, the former shall prevail.


